PARISH ASSEMBLY

An Assembly of the Principals and Electors of the Parish of St Clement was held at the Parish Hall on Tuesday 23 February 2021 at 7.00pm to: -

1. Consider the following applications for recommendation to the Licencing Assembly: -

1. (a) Mr Joao Bento spoke on behalf of Wine Consultants (Channel Islands) Limited advising that the premises would not be open to the public. The aim of the business is to provide a bespoke management and consultant service for home cellars and wine and sprit collectors, any wine would be stored in a private cellar in Bellozane Road, St Helier.

Mr John Pinel asked if this would be an online service and Mr Bento advised that it would not. Their aim was to provide specialist consultancy services for home cellars which may require the sale and purchase of fine wine and sprits on behalf of their clients hence the requirement for a licence. This type of business is rare in the UK but popular in Switzerland and France. Mrs Jannine Bento (Company Secretary) added that initially they had applied for a licence for the cellar premises in St Helier but had been advised by Andrew Jones, the Government of Jersey Hospitality and Leisure Manager, that as the administration would be carried out from 5 Fairways, that was where the company resided and the premises for which the licence should be held.


On the proposition of Mr Simon Mountford and seconded by Mrs Rita Wilson the Assembly unanimously approved the application by Wine Consultancy (Channel Islands) Limited for a sixth category (Off-Licence) for 5 Fairways.

- (b) Miss Sharon Doherty spoke on behalf of The Mad Platter Jersey advising that the business supplied themed food/platter boxes in some of which they wished to also provide a mini bottle of wine or prosecco. There will not be large amounts of alcohol stored on the premises, it would be purchased as required.

John Pinel asked if the business would have many clients visiting the premises. The platters would be ordered by social media/telephone and would be delivered directly to the clients. However, collection would be an option, but it was envisaged that this would not be the norm.

On the proposition of Mrs Victoria Buckley and seconded by Deputy Lindsay Ash, the Assembly unanimously approved the application by The Mad Platter Jersey for a sixth category (Off-Licence) for Sandy Croft.

Mr Pinel was advised that if he wished, he could attend the Licencing Assembly in the Royal Court at 10.00am on Thursday 18 March 2021.
