

## Parish Assembly

An Assembly of the Principals and Electors of the Parish of St Clément was held at the Parish Hall on Tuesday 4 July 2023 at 7.30 pm to:-

- 1. Elect a Vingtenier for the Vingtaine of Roquier.
- 2. Elect a Vingtenier for the Vingtaine of Grande.
- 3. Elect a Constable's Officer for the Vingtaine of Samares.
- 4. Receive, and if deemed advisable, adopt the accounts of the Connétable for the financial year ending 30 April 2023; the said accounts having been previously examined and approved by the Committee appointed for that purpose, and audited by the Parish Accountants, PKF BBA Audit and Assurance Limited.
- 5. Approve the estimates of the funds required by the Parish for the financial year ending 30 April 2024 to include a sum of money for the upkeep and maintenance of the by-roads and a sum of money for the purpose of making grants to various Charities and Organisations to be allocated by the Connétable and Procureurs du Bien Public.
- Approve a rate of an amount that will produce for the Parish income that is at least sufficient to satisfy the requirements as set out in the approved estimates.
- 7. Receive nominations and name a committee to examine the Connétable's accounts for the financial year ending 30 April 2024.
- 8. Appoint a firm of auditors to audit the Connétable's accounts for the financial year ending 30 April 2024.

- Miss Kristina Bocyte was duly elected as a Vingtenier for the Vingaine of Roquier having been proposed by Mr Sebastian Boyes-Southern and seconded by Miss Liliana Mesquita.
- 2. **Mr Mark Drumel St John Watkins** was duly elected as a Vingtenier for the Vingtaine of Grande having been proposed by Mrs Tracy Cornick and seconded by Miss Liliana Mesquita.
- 3. **Mrs Susan Elizabeth Pace** (nee Wright) was duly elected as a Constable's Officer for the Vingtaine of Samares having been proposed by Mr Ricardo Henriques and seconded by Mr Philip Heard.

- 4. On the proposition of Mrs Rosemary Norman and seconded by Mrs Susan Pearmain, the Assembly unanimously adopted the accounts of the Connétable for the financial year ending 30 April 2023.
- 5. On the proposition of Mr Richard Lagadu and seconded by Mr Neville Falla, the Assembly unanimously approved the estimates of the funds required by the Parish for the financial year ending 30 April 2024 a total sum of £1,156,740. This included the sum of £77,000 for the upkeep and maintenance of the by-roads and the sum of £12,000 for the purpose of making grants to various Charities and Organisations as allocated by the Connétable and Procureurs du Bien Public.
- On the proposition of Mrs Rosemary Norman and seconded by Mrs Barbara Ward, the Assembly unanimously approved a rate of 0.0112 pence per quarter.
- 7. On the proposition of Mr Neville Falla and seconded by Mrs Collette Willmett, the Assembly unanimously agreed that the current members of the Committee to examine the Connétable's accounts be re-elected, namely, the Procureurs du Bien Public, the Deputies, the Rector, the Churchwardens, the Chef de Police and Mr Garry Beardshall, and in addition, Mr Andrew Jelley should also be elected to the Committee.
- 8. On the proposition of Mrs Rosemary Norman and seconded by Mr Richard Lagadu, the Assembly unanimously agreed that PKF BBA Audit and Assurance Limited be re-appointed to audit the Connétable's accounts for the financial year ending 30 April 2024.

The Assembly was attended by 23 Parishioners.
